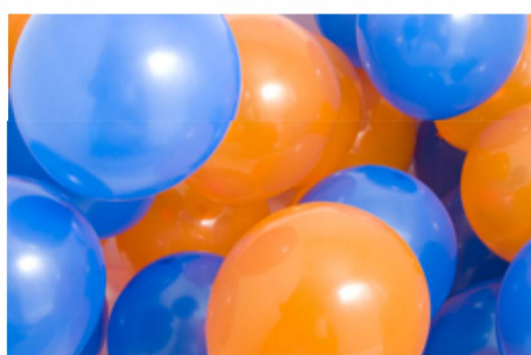

South Carolina Federal will not be responsible for any finance charges or late fees incurred due to your nonpayment. Any balance transfers processed after the promotional period will incur finance charges at the standard rate. Twelve-month promotional rate will begin the business day the transfer is made. At the conclusion of the 12-month period, any remaining balance will incur finance charges at the standard rate.
